Signs and other devices (excluding inflatable devices) may be displayed for a maximum of 30 days within a 90 - day period to promote a particular event, sale or product. The total area of all temporary signs and banners for each business shall not exceed 40 square feet. Signs shall not be painted on any surface other than glass windows or doors. Temporary window signs - Section J.
